



Assumption of Risk and Liability Waiver

I, the undersigned ("Participant"), in consideration for Legacy Preschool allowing my participation in the above named School Year or Event (the "Activity"), I agree to the following:

Waiver of Liability: Participant understands that there are inherent risks associated with the Activity (the "Risks"), and Participant's involvement in the Activity may result in bodily injury, illness, incapacity, disability, dismemberment and death, as well as the risk of property damage and economic loss. Participant agrees to assume all Risks while Participant is involved or participating in Activity and hereby waives any and all claims or actions that may arise against Legacy Preschool or its officers, employees, contractors, volunteers as a result of such Risks. These Risks include, but are not limited to: (1) Injuries arising from Participant's use of any equipment or tools in connection with the Activity, whether occurring inside or outside of Legacy Preschool School campus, (2) Injuries arising from Participant's transportation to and from a site that is a part of the Activity, (3) Injuries or medical disorders arising from Participant's participation in the Activity, whether occurring within or outside of Legacy Preschool or Legacy Chapel, (4) Injuries resulting from actions taken or decisions made by Legacy Preschool/Chapel, its staff members, volunteers or chaperones regarding medical or survival procedures for Participant, (5) Risks of illness due to close proximity with other individuals, including, but not limited to, other participants and representatives of Legacy Preschool, which might result in the transmission of pathogens and infectious diseases, such as coronaviruses, bacterium, flu, and fungus, and (6) risks of all other forms of harm, whether known or unknown, foreseeable or unforeseeable.

Assumption of Risk and Indemnity: As an additional material inducement for Legacy Preschool to allow participation in the Activity, the undersigned agrees that he or she understands and voluntarily unconditionally accepts all of the Risks on behalf of Participant. The undersigned agrees that Legacy Preschool, its employees, agents, representatives, and volunteers will not be liable for any injuries, illnesses, liabilities, claims, actions, damages, losses, costs, or fees of every kind or nature (including, without limitation, attorneys fees) regardless of whether caused by the negligence or other acts of Legacy Preschool or anyone else leading, participating in, or guiding the Activity. As an additional material inducement for Legacy Preschool to allow participation in the Activity, Participant agrees to indemnify, defend, and hold harmless Legacy Preschool, its employees, agents, representatives, and volunteers from all claims arising out of in any way related to the Risks or participation in the Activity that may be asserted by Participant.

I have read the Waiver of Liability and Assumption of Risk thoroughly and understand the terms. My participation in the Activity and my execution of the Waiver of Liability and Assumption of Risk are both purely voluntary and I elect to do so in spite of any and all inherent or remote Risks to the Participant.
